#### RSAT Case 11-2603: Destruction of Australian F-111 Aircraft and Engines

- 1. On 24 August 2011, Principal Deputy Director, U.S. Office of Regional Security and Arms Transfers approved the permanent transfer of Australian F-111 aircraft and TF-30 engines for destruction. The approval required a copy of each of the relevant Certificates of Destruction to be provided to the U.S. DoS Office of Regional Security and Arms Transfers as well the U.S. Office of Defense Cooperation in Canberra.
- 2. The destruction and disposal of 23 F-111 aircraft and 130 engines has now been completed by Birdon Pty Ltd and their subcontractor Transpacific Industrial Solutions Pty Ltd in accordance with the terms of the contract between the Commonwealth of Australia and Birdon. Enclosures 1 to 5 provide copies of the corresponding Certificates of Destruction. Copies of the Certificates of Destruction have also been forwarded to the U.S Office of Defense Cooperation in Canberra. Enclosure 6 to this letter provides a summary of the demilitarisation and disposal actions performed on the aircraft and engines. # ENCLOSURE 6 TO AUSTRALIAN F-111 DESTRUCTION NOTIFICATION

#### SUMMARY OF DEMILITARISATION AND DESTRUCTION ACTIONS

1. The surplus Australian F-111 aircraft, engines and related major components were subjected to final disposal in November and December 2011. This document summarises the processes that were applied to the disposal of the surplus aircraft, engines and related major components.

#### **Fuselage**

- 2. Prior to commencement of the fuselage disposal activity, each fuselage was subjected to a disposal preparation servicing. This servicing included:
  - a. removal of all classified items;
  - b. removal of all explosives;
  - c. removal of all processors from the forward equipment bays;
  - d. removal of the radome and all radar heads; and
  - e. removal of wings, horizontal stabiliser, vertical stabilisers and engines.
- 3. The Commonwealth contemplated total destruction of the fuselage but determined that total destruction had the potential to release asbestos fibres from the bonded panels that are prevalent throughout the aircraft's surface and internal structures. Removal and separate management of the bonded panels was impractical due the level of resources that would be required and the hazards likely to result from the uncontrolled loss of the structural integrity of the fuselage during bonded panel removal. Furthermore, several of the structural bonded panels cannot be removed without damaging the panel edge members and thereby creating the risk of asbestos fibre release.
- 4. In order to minimise the risk of asbestos fibre release, the Commonwealth buried the fuselage after demilitarising the key points in a manner consistent with the Appendix to Enclosure 3 of DoDM 4160.28-M-V3, June 7, 2011 (Defense Demilitarization Manual). The specific demilitarisation actions performed on the fuselage may be summarised as follows:






Figure 1: Typical Demilitarisation of Left Hand Wing Attachment Lug




Figure 6: Typical Removed Longeron Segment

  - a. <u>Wing Attachments.</u> A section of one of the wing attachment lugs has been cut from each side of each aircraft. Figure 1 and Figure 2 show typical wing attachment lugs after completion of the cutting process. Figure 6 shows a photograph of typical removed sections of the wing attachment lugs.

- b. <u>Fuselage Longerons.</u> A section was cut from each of the left and right main fuselage longerons at a location between the Wing Cary Through Box and the horizontal stabiliser attachment points. Figure 3 shows typical longerons after demilitarisation treatment while Figure 6 shows a photograph of typical longeron segments removed from the aircraft.
- c. <u>Horizontal Stabilisers</u>. Both the left and right hand horizontal stabiliser attachment fittings were cut to prevent the re-attachment of the stabilisers. Figure 4 shows a horizontal stabiliser attachment fitting after cutting. Typical removed sections of the stabiliser attachment fittings are shown in Figure 6.
- d. <u>Vertical Stabiliser</u>. The vertical stabiliser attachment points were destroyed by cutting to prevent the re-attachment of the vertical stabiliser. Figure 5 shows typical vertical stabiliser attachment brackets after cutting. Figure 6 shows a portion of a vertical stabiliser attachment bracket typical of the sections removed from each aircraft.

5. On completion of the demilitarisation actions described in paragraph 4, the fuselages were transported to a controlled waste disposal site. The waste disposal site is fenced and patrolled and access to the site is controlled through restricted access points. Holes were dug in the ground to accommodate both the nose and main landing gear so that the fuselage would rest on its belly. The fuselages were positioned in tight formation, were trampled by a bulldozer and were covered with at least one metre of soil and general refuse at the conclusion of each day. On positioning of the last fuselage, the site was sealed with soil and released to general waste disposal. Over the next five years the aircraft are expected to be buried under 60 metres of refuse. Figure 7, Figure 8, Figure 9 and Figure 10 show the burial process and the layout of the burial site.

#### Wings

- 6. The F-111 wings were processed for disposal as follows:
  - a. Items potentially containing asbestos (flaps, slats, leading edges and actuators) were removed by cutting attaching brackets.
  - b. The wing root structure and pivot fitting (including boron fibre doubler) were removed by hydraulic shearing (refer Figure 11).
  - c. The removed items were buried with the fuselages (refer Figure 12).
  - d. The remnant wing planks and wing structure were destroyed by shredding (refer Figure 13).

#### **Vertical and Horizontal Stabilisers**

7. The vertical and horizontal stabilisers are predominantly manufactured from bonded panels and hence may contain asbestos fibres embedded in the adhesive bond surface. Destruction of the vertical and horizontal stabilisers had the potential to release asbestos fibres. Accordingly, the vertical and horizontal stabilisers were buried intact with the fuselages.

#### **Engines**

8. The engines were processed by plasma cutting to remove the asbestos containing materials dispersed throughout the engine. The engine was then shredded to achieve total destruction and to produce residue suitable for recycling. Figure 14, Figure 15, Figure 16 and Figure 17 show various stages of the engine disposal process.
